#### ABOUT AMPLE PROGRAMME

The Citi Foundation launched its first ever Global Innovation Challenge in February 2023 to help scale the impact of nonprofits around the world that are developing innovative solutions to improve food security. EIT Food was one of the 50 organizations worldwide to receive funding from the Citi Foundation to design and pilot the AMPLE Programme to strengthen the physical and financial health of low-income communities. The Programme started in Madrid in October 2023 and runs until 30 September 2025.

AMPLE provides training courses, learning resources and networking opportunities to vulnerable communities to help them enter the agrifood labor market. EIT Food is working with 3 non-profit organizations to run training courses focused on healthy and sustainable cooking, regenerative agriculture, and agrifood entrepreneurship.

Another important goal of AMPLE is to support startups and small businesses (SMEs) in the agrifood sector to improve their production process and create healthier and more sustainable products. AMPLE is distributing 30 'Boost Vouchers' (small grants of Euro 2300) to agrifood startups and small businesses to encourage innovation and create healthy food alternatives.









#### WHAT ARE WE LOOKING FOR?

EIT Food is recruiting agrifood SMEs and startups with **economic activity in Madrid providing services/products**, which can benefit from **small grants (€2.300)** to become more sustainable while addressing the issue of food insecurity.

Related to EIT Food's mission, <u>Healthier Lives Through Food</u>, AMPLE is giving **economic support** to agrifood SMEs and startups to find innovative solutions for affordable products. We want to encourage SMEs to **improve their production process or innovate the properties of a food product** to provide more affordable, accessible, and healthier food in Madrid.

The activity leading to improvement should take place and be reported on 6 months after the activity started. We particularly encourage applications from businesses led by underrepresented groups.

#### Main duties & responsabilities

- Put in place an action plan to improve the business to produce more affordable, accessible, and healthier food.
- Promote the award of the boost voucher mentioning the Ample Programme, EIT Food and Citi through social media and website.
- Actively participate and promote the events related to Ample through social media and website.
- Continuously coordinate with the EIT Food team to effectively implement the action plan and receive feedback.
- Prepare a final report that provides a comprehensive overview of the accomplishments: description of the implementation process, points of sale, number of sales and profits, and job creation after improvements.
- Respect the <u>EIT Food branding guidelines and visuals</u> in any communication material.

# **SELECTION PROCESS**

Interested and eligible companies are invited to **submit their applications before 30 April 2025, 23:59 pm CEST**, conditioned by fund availability, via email with the title **"AMPLE: Request for boost vouchers"** sent to: **leticia.lopez@eitfood.eu** 

The startups/SME selected will sign a contract agreement with EIT Food ivzw. EIT Food will pay the total amount of the boost voucher on receipt of an invoice from the start up or SME.

All applicants will be evaluated considering the following criteria as they relate to the AMPLE programme voucher:

- Level of **Practicality** of the proposal
- Level of Quality of the proposal
- Level of Viability of the proposal
- Level of Impact of the proposal

The above criteria will be evaluated on a 0-5 scale, the application can receive a maximum of 25 points. The applications must reach a minimum of 15 points to access the grant. Each evaluation sub-criterion will be scored from 1 to 5 using the following scoring system.

Score		Description
0	Not addressed	Not addressed
1	Poor	The criterion is inadequately addressed, or there are serious inherent weaknesses
2	Fair	Application broadly addresses the criterion but there are significant weaknesses









3	Good	Application addresses the criterion well, but a number of shortcomings are present
4	Very good	Application addresses the criterion very well, but a small number of shortcomings are present
5	Excellent	Application successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.
