# 1. The PoC idea

## Describe the problem you address

Describe the problem or the need that the idea is aiming to solve or alleviate. Substantiate this need with relevant data. Please make sure that you refer to one of the three aims in the Call Guidelines.

When describing the problem, make sure that you are addressing the challenges faced by your concrete target audience and the area where you will intervene. Avoid including a very general description of it.

## Describe what is your proposed solution, expected impact and workplan

Explain how 1) your idea (solution) might either improve the target group's situation, impact their behaviour or thinking or strengthens their understanding about a problem/solution; 2) what you expect to achieve with the implementation of your Proof of Concepts: and 3) your workplan for the six months.

This section should include information on:

- Impact: what effect will your intervention have in the economy, society, culture, public policy/services, and how you will assess this impact.
- Reach: how many people the PoC will reach directly and how this contributes to societal potential.
- How and where you will test and validate the potential of the PoC and its outcomes, how many consumers will you engage during the PoC stage (This will become the PoCs KPI)
- How you will collect or develop knowledge of your target group behaviour.
- Workplan: key strategy, methodology used and planned tasks and timing of the PoC.

When filling out this section, please have in mind your target audience, location and the expected impact you are aiming to have in your target audience.

Max 1000 words.

#### Consortium, network and staffing

For the PoC phase you can apply as an individual organisation or as a consortium. If your PoC becomes a full project, it will need to be implemented by a consortium.

Please describe the skills needed to achieve the societal impact potential of your idea and who in your consortium already has the needed skills.

If you are applying as an individual organisation or if your consortium does not have all the long-term skills required if the PoC becomes a full project, describe how you would go about creating the skill set needed to be able to implement the full project. What steps would you take during the PoC stage and what contacts would you set up with industrial partners, societal or cultural organisations, policy makers or any other potential users or sponsors of the project's results to maximize impact.
