Protein Diversification

Digital Traceability

Develop food supply chains that make the Food System Safe, More efficient, Sustainable and Transparent.



Sustainable Agriculture

Targeted Nutrition

Call for Proposals 2023: Introduction





Call Summary

Proposal Submission	This call for proposals offers two submission deadlines: • 14 October 2022, noon CET	
	• 13 April 2023, noon CET	
Consortium	Minimum 3 organisations from at least 2 different eligible countries representing at least two sides of the knowledge triangle.	
Expected size of individual proposals (EIT grant amount)	 Indicative maximum EIT grant amount (a reimbursement amount of eligible costs, excluding co-funding): Up to 600.000 EUR per Activity for 12 months. Up to 1,2 million EUR per Activity over a maximum of 24 months. 	
Maximum duration of a project	Activities may last up to 24 months	
Maximum reimbursement rate & co-funding	EIT Food will fund up to 70% of total eligible costs of the Activity (reimbursement rate). The consortium must co-fund a minimum of 30% (co-funding)	





Introduction to Call for Proposals 2023



EIT Food is calling for proposals to start activities in 2023:

- Activities that will develop innovative products, processes and services that address a specific business opportunity that will result in commercial exploitation
- Innovations that will benefit the European citizen.

Proposals responding to this call <u>must include</u> the following key elements:

- Propose at least 1 near-to-market, commercially viable innovative technology solutions (goods, services, processes or products) in line with EIT Food Missions, Focus Areas & Challenges
- Minimum TRL level 5 at the time of the proposal submission (level 4 completed and proved)
- must launch at least one innovative solution (marketed innovation) no later than 6 months following the official end date of the project, including proof of revenue generated of at least 10.000 EUR





Innovation activities and outcomes



Innovation Activities EIT Food is funding:

- Translating or repurposing current technologies
- Co-creation activities with consumers
- Demonstration activities
- Joint funding of competitive challenges

Resulting in:

- Products or services new to the market
- Exploitable IPR
- New business models
- Novel processes





Mandatory KPIs

Proposals must include the following mandatory Innovation KPIs:



<u>EITHE02.4</u>: At least one Marketed Innovation: Projects must deliver at least one marketed innovation, including documented and valid sales revenue of at least 10.000 EUR (ten thousand euros) in the year the KPI is to be delivered, and no later than 6 months following the official end date of the Activity.

<u>EITHE16: Continuously disseminated results/GP/LL:</u> Results from the project should be continuously disseminated: number of results, good practices and lessons learnt.

Recommended KPIs

<u>EITHE04.4: Start-ups established</u> in year N as a result/ based on the output(s) of Innovation/ Research related KAVA(s), or start-ups created for the purpose of an innovation project to organise and support the development of an asset (but not later than 3 years after completion of the KAVA).



Updated: Financial Sustainability Principles

A return on investment for EIT Food to gradually become financially independent from EIT funding, also as a "success fee".

Updated: Financial Sustainability Principles



Phase 1 – Market Entry

Timing: Y1

Objective: fixed initial return on majority of innovation projects

Mechanism

- Returns equal to 30% of EIT funding:
 - 10% at 3 months following project completion
 - 20% at 15 months following project completion
- If exploiting party is not returning, IP recovery and exploitation process is initiated

Phase 2 - Scale

Timing: Y2-4

Objective: fixed return on innovations

with stable growth/success

Mechanism

- Returning 100% of EIT funding:
 Exploiting parties propose a credible and verifiable milestone based path which are monitored quarterly by key account manager
- Exploiting parties define the milestones during project proposal
- No IP recovery process if milestones are not met

Phase 3 - Maximize

Timing: Y5>

Objective: Capitalize on above average

successes (stars and cash-cows)

Mechanism

- Uncapped return mechanisms
- Great extent of flexibility as long as both parties benefit. Can be milestone-based, equity, revenue sharing, royalties etc.
- Exploiting parties propose FRM mechanism during project proposal, but there is a possibility for re-negotiation of terms and conditions







Eligibility & Evaluation Criteria





Who can apply



This call is open to all organisations eligible for Horizon Europe funding, you do **not** need to be an EIT Food partner to submit a proposal.

Strategic partner

Strategic partners are organisations who want to be involved in setting the strategic direction of EIT Food and have a strong influential voice at sector and policy levels both in the EU and beyond.

Eligibility Criteria for any participating organisation

- ✓ Be a legally incorporated entity in the EU or Horizon Europe eligible country, which has been incorporated for a minimum of 3 years
- ✓ Have at least 3 years' published accounts showing business
 Activity. Note: EIT food will limit the grant value to 50% of
 turnover, based on the average turnover of the previous 3 years
- ✓ Have at least two statutory officers, such as registered directors.

 One-person legal entities are not eligible to participate in this call
- ✓ Provide a PIC Number: Register your organisation in the "Funding and Tender Opportunities Portal – European Commission"







Eligibility Criteria for Consortia



- 1. Partnership size: the consortium must include at least **three eligible organisations** (under Horizon Europe eligibility rules)
- 2. Geographic diversity: to ensure European impact and relevance, the minimum requirement is to involve partners from at least two different eligible countries
- 3. The consortium must include at least one Exploiting Partner that will launch the new or improved innovative solutions (product, service, start-up, process).
- 4. The consortium must contribute to *Knowledge Triangle Integration* by involving organisations from **at least two fields of the knowledge triangle** education/academia and research and business/industry, representing different areas of the food system.

Important! Any proposal not meeting all the eligibility requirements will not be considered for funding.





Proposal Eligibility Requirements

All proposals applying for this call must submit the following <u>mandatory requirements</u> to be eligible for evaluation:

- 1. Mandatory KPIs
- 2. Minimum Co-funding 30% / Reimbursement Rate 70%
- 3. Comply with the Financial Return Mechanism
- 4. ALL Mandatory Documents must be uploaded in the application form (PLAZA)
 - Gantt chart
 - A Business Model Canvas
 - A Criticality template
 - Proof of TRL 5 or above (TRL 4 completed and demonstrated)
 - A Commercialisation and Revenue Sharing Mechanism template





Evaluation Process & Criteria




External Experts will evaluate Part A of all applications which pass eligibility and include based on the following criteria and weighting:

- Excellence: 40%
- Impact Pathways and KPIs: 30%
- Quality and Efficiency of Implementation: 30%

Proposals that will proceed to PART B of the evaluation process, will be evaluated by External Experts, based on the following criteria and weighting:

- Excellence and Implementation: 40%
- Compliance with Financial Sustainability Principles: 30%
- KIC Portfolio Strategic Fit, Impact & KTI: 30%
